Since 2017, we have had thousands of conversations with Medicaid members and in the past three months have collected more than 700 stories from Medicaid members and I have them all here with me today. These stories from Medicaid members, their loved ones, faith leaders, small business owners, healthcare workers, many of the people who wrote these stories are here with me today and I'm proud to stand with them. You'll hear some of their stories at this press conference. And following the press conference, we'll send a delegation to deliver them to governor's office along with a card asking him to fight for future healthcare and no cuts to Medicaid.

What unites all the Medicaid stories we collected and all the people here today across faith, race, place, age, ability, and geography is an undeniable truth. The truth that all of us, all human beings need and deserve healthcare regardless of how much money we have. We all have bodies. We all get sick and none of us should go broke because of it. Today we know that whether or not we ever end up needing Medicaid, it benefits all of us. It's a public good for our communities. Medicaid covers 2 million Hoosiers enabling them to access lifesaving lifesaving treatments, preventative care and palliative care. But Indiana Medicaid is under attack. Proposed states and federal cuts to Medicaid programs risk the lies health and economic stability of all of us. Whether these costs come in the form of slashing the federal budget, capping Medicaid enrollment or I burdensome new red tape with the goal of surprising lowest income families of their healthcare coverage.

We'll not be fooled by attempts to divide and distract us. We'll not accept any cuts to our care to fund tax cuts for billionaires together and defeated an attempt to impose Medicaid work reporting

requirements on Hoosiers, which would've deprived an estimated 75,000 members of their healthcare coverage. And when Senate bill to was filed at the start of this year, be again organized thousands of phone calls, emails, and meetings with legislators and oh, it's not. Okay, there we go. And as a result of those efforts, we removed first the three year enrollment cap to hip and then the arbitrary 500,000 person hip membership cap put two dangerous provisions, which would cut Medicaid covers Medicaid members off of their care remain in SB two. The requirement that SSA implement more frequent eligibility checks to all Medicaid programs and add work reporting requirements to him. Yeah, that ain't right. These provisions will not only lead to dangerous coverage loss for sier families, they will also make Indiana's Medicaid programs more inefficient and more expensive to run, wasting public dollars that should go to funding our care. And we'll defeat these cuts too because as you'll hear today, our lives depend on it. We don't have an option not to fight. Thank you.
